SKILLS DEVELOPMENT ACT 97 OF 1998

AMENDMENT OF REGULATION 14(2) OF THE SETA STANDARD
CONSTITUTION REGULATIONS

I, Hlengiwe Buhle Mkhize, Minister of Higher Education and Training, after consultation with National Skills Authority, hereby amend Regulation 14(2) of the SETA Standard Constitution Regulations published under General Notice No. 369 of 11 May 2012, in Government Gazette No. 35336, by the following:

(2) Term of office of Chairperson

- (a) The term of office of the Chairperson **[is five years]** may not exceed the period for which the particular SETA is established.
- (b) The person appointed as Chairperson may **[only]** not serve **[one]** for more than two terms of office in **[a]** the particular SETA.
